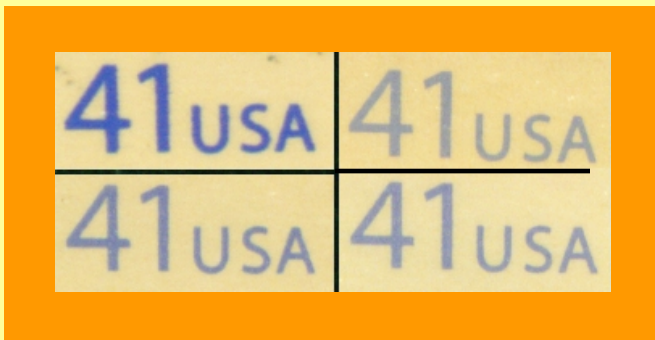

## 100% # on Top Census

As a PNC<sup>3</sup> member (#2114) I've been trying to put together a comprehensive listing of plate-#-100%-on-top coils, at first for the Transportation series (my personal interest). But the project has grown to include everything else (flags, bees, etc.) as well. This is an invitation for my fellow members to help in a "census" (as Editor Ron Blanks calls it). All information will fold into my research and later be reported in a future Coil Line (and on the club website) for everyone to access.

For this census, the criterion is simply put: A plate-#-100%-on-top coil is any coil where the plate number is within the top half of the stamp, and in which the entire plate number is clearly visible below the top cut (no splits or partials or almost-maybe 99%, please). (*See example above.*)

Information should include strip length, mint or used (or cover), imperf, precancel (PC) gaps, top and bottom # (on same stamp) cases, tagging types, and color types. (*please see page 88*)

PNC<sup>3</sup> always welcomes your mint postage, even of presort coils. Send donations to The Incredible Mailing Co. Their street address has now been added to the second page of every issue for the benefit of those who receive the electronic edition of *Coil Line*.

## Readers' Forum

**The President's Message** in the *May Coil Line* peaked my interest. In that column, President Ron Maifeld posited the question of why our membership took such a huge "hit" in the last membership renewal period. I've wondered the same thing, and I'm pretty-much certain that it has to do with the current economic downturn.

Remember, the current recession is the worst economic downturn since the Great Depression of the 1930s, which only ended when World War II defense spending began in earnest in late 1941.

**I thought you** might like to see the enclosed 41¢ Flag on Pole (Scott 4187) printed by Sennett Security Products (*shown above column at right, along with a typical used stamp off-paper*). This is one of five examples I found in a mission mixture. One of them was a PNC #S11111. The "41 USA" is a dark blue, as is the last "1" of the plate number.

It will be interesting to learn of possible explanations for this apparent color difference, since the inks used for this format from Sennett were specified as Pantone Matching System (PMS) colors, with very little overlapping used in the design. (Only the flagpole and left edge of the flag show overlaid-ink use, that of the black ink.)*

*I examined all of my used off-paper and on-cover examples of this coil, and found only the typical light-blue inked "41 USA". I selected an assortment of off-paper stamps to show the range of color appearance along with the dark-blue example (see front cover).*

It was Tom who last September sent in two mint strips of the 42¢ Flag affixer coil, one of PNC V1111 and one of V2222. Both were from large rolls with the stamps spaced apart on liner paper for affixing machine use in preparing large mailings. Thanks to Tom's material, we were able to show in the November 2009 issue close-ups of the die-cut shapes for each. (V1111 has the "more rounded" transition shape from a corner to the first peak or valley, while V2222 has the "more angled" shape.)

It was also Tom who sent in the dramatic die cut misalignments we showed in the December 2009 issue of mint 44¢ Flags of our Nation (third set). Tom also carefully scrutinized coils on-cover, and in that same issue shared an example of an Avery dramatic die-cut shift on a 41¢ Flag coil. What he actually collected I never knew. I was just impressed all along with his enthusiasm and genuine curiosity about the coil stamps that came his way. He exemplified some of the best traits of

an engaged *Coil Line* reader and PNC<sup>3</sup> member, and his contributions will be sorely missed.

# Tagged Atlas PNC Fetches High Price

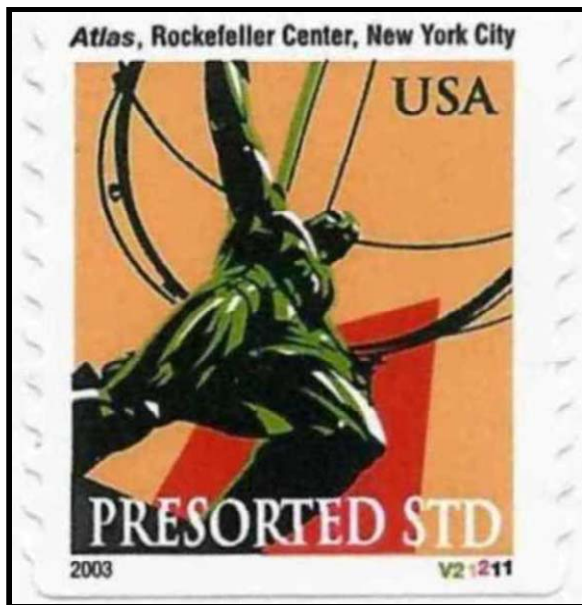
A rare variety of a common non-denominated (10¢) Atlas presort standard-rate coil stamp has recently changed hands between two anonymous collectors. The used Atlas single, bearing plate number V21211 and with full phosphor tagging, fetched the handsome sum of \$1900 in a private treaty sale between members of the Plate Number Coil Collectors Club this past mid-April.



Normal Atlas stamps printed by Avery Dennison do not exhibit tagging. This one was printed in error on prephosphored paper. Originally, a non-numbered copy was discovered by Ron Blanks in December 2007, and reported in the June 2, 2008 issue of *Linn's Stamp News*. (Editor's note: The picture shown above was taken under shortwave ultraviolet light of that stamp still on paper, along with a normal untagged version for comparison.) The plate number V21211 was associated with the tagged error by PNC<sup>3</sup> member Rob Washburn on June 3, 2008 based on a commercial cover he located in his possession. This cover, bearing the tagged V21211, was reported in the July 2008 issue of *Coil Line*. I also reported a confirming copy of a used PNC single in the August 2008 issue of *Coil Line*.

Since that time, only two additional used copies of the tagged error (both PNCs of V21211) have been reported. There are no known mint strips of this elusive error. PNC specialists have been looking in vain in their collections and duplicates to identify additional copies. The latest copy (the third used single off-cover) was discovered in mid-April of this year in a mixture purchased from a Nebraska mixture dealer.

Avery Dennison produced the (10¢) Atlas coil stamps bearing the "Presorted Standard" designation for use by authorized mass mailers. (Editor's note: When used on mail, each stamp counts as ten cents towards the actual mailpiece postage required. These mailers obtain discounted postage rates from the U.S.

Postal Service when their mailings are prepared according to complex guidelines that reduce handling in the mailstream.) They were first released in October 2003 without a first day ceremony. Our PNC<sup>3</sup> website ([www.pnc3.org](http://www.pnc3.org)) reports nationwide USPS sales of the Atlas printed by Avery Dennison began on October 29, 2003. The original format released was rolls of 10,000, and rolls of 3,000 were released later in September 2004.

It should be noted that Atlas stamps of similar design printed by Banknote Corporation of America (plate number B111) were also normally printed on untagged paper, but some copies have been found that exhibit light (weak) tagging characteristics. These are much more common than the fully phosphor-tagged error examples now known from the Avery Dennison plate V21211.

# Catalog Corner

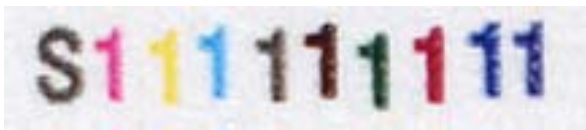
Set Four in the series of self-adhesive (SA) 44¢ Flags of Our Nation stamps from Sennett Security Products went on sale April 16, 2010 nationwide (although it was not widely available at post offices on that date).

The S111111111 plate number in the lower-right hand corner repeats every 10 stamps along the roll, found on every Flag over Mountain stamp (*shown at left*).

Like the previous three Flags of our Nation sets, these come in rolls of 50.

The first stamp on the roll is the Flag over Mountain. This is followed by other states in alphabetical order as shown below. The last stamp before the designs repeat is the North Dakota Flag stamp. All stamps have a peak/valley (PV) die cut.

A leader strip identifies and seals the roll. An example of the leader strip is shown at the bottom of the page.

(From Dec. 2009:) **#V333** is now known for the (10¢) **Banner**, so far on-cover only. Also, the (25¢) Eagle Self-Adhesive 10k coil #S3333333 is now known with smooth tagging<sup>#</sup>. This coil has no black line on the liner.

'KEY' box was updated Dec. 2008 with phosphor tagging terms finalized at specialists' meeting (APS StampShow, Hartford Aug '08): **EP** for stamps with Embedded Phosphor, and **SP** for Surface Phosphor stamps. SP stamps have an additional qualifier letter: **-U** for Uneven and/or Grainy, or **-S** for Smooth appearance.

Ashton Potter's SA Sea Coast P2222 was die cut two ways. One is serpentine cut on all four sides; the other only on the sides. In printing the Sea Coast with cylinders P2222 through P9999, AP changed the cylinder size from that used to print P1111. Thus, the plate number intervals changed from 22 to 27. P3333 through P9999 have a small date and color order of BCMY.
