



About 20 percent of club members have taken advantage of 'Handbook'

Arthur Westneat estimates about 20 percent of the membership has taken advantage of the PNC Handbook service he has offered the past couple of years.

Westneat copies data files from the PNC3 Web site into double-sided pages. The result is a loose leaf set of more than 200 sheets, weighing almost three pounds. The pages are photocopied, punched, packaged and mailed for a total price of \$19. He reports the price is as low as it is because he found a print shop that requires a 75-mile roundtrip.

He has also provided supplements as pages are updated and added to the database. At age 83, Westneat said the effort serves as a diversion for him and he is willing to continue as long as he is able and there is an interest.

The Catalog ... Your part

In early December 2003, your catalog committee finished preparing the catalog offerings listed on the order form in this issue of *Coil Line*. The Committee printed sample copies for themselves and selected reviewers. During the past month and a half a review process has taken place to make corrections and improvements to the pages offered.

A feedback form will come with the pages ordered. This is your chance to suggest improvement or make comment on the catalog offerings. A feedback form returned from a PNC3 member after reviewing the 2003 Catalog Sampler, suggested we allow space for additional plate numbers for issues still active.

This year on the reprint of the 37c Flag Waving (BEP), space was left to add six new plate numbers and on the 23c Washington pages two extra spaces are available.

The catalog pages show both PNC ID and Scott Number, but if you use some other identification scheme, a blank field titled "Other Identifier" has been provided. This field could also be used to identify the page or album where the issue can be found in your collection.

On the "2002 Updates only" pages, the page number has been left intentionally blank. Some members will replace Sampler pages purchased last year with these pages. The number of pages for the 37c Flag Waving and the 23c Washington have increased. Some will want to keep last year's pages and add the new pages behind them. Pages published at different times can be distinguished from one another by the month/year date stamp at the bottom of each page.

Our intent is to make the pages of your catalog as complete as possible. If you know of images left out or other information you would like included, please let us know. For example, we have had several reports of an imperf plate 4444 of the 37c Flag Waving (BEP), but the owner (s) are not known. The image would be a nice addition to our catalog pages.

Scott Adams sent me a cover proving the existence of the 25¢ Eagle #S3333333. See above.

A 9.3¢ Mail Wagon #3 PNC tied on cover by a June 4, 1983 postmark has been found. The previous EKU for that number (on a cover carried through the mail stream) was January?, 1986. A 32¢ Flag/Porch SA #S11111 PNC has been found on a cover cancelled August 26, 1996, three months earlier than the previously recorded EKU on cover.

SNIPPETS

FOP 66666 12/11 Sold - Big Money

One of the five known numbered copies of the rare Flag Over Porch #66666 12/11 has been sold and is the first one to ever change hands. Dealer Jim Nelson bought the used copy outright and resold it through a closed auction for a record price of \$3,500. There were only four bidders who met the reserve initially and only two were in the game when the winning bid was placed. The buyer wishes to remain anonymous. As far as I know this purchase price is the most ever paid for a used PNC single. The four other owners now have a market price to place on their holdings. Two of those four hold covers which could possibly have even a higher value.

Washington Numbers Change Size

A lot has been said about the die cutting on the 23¢ George Washington coil and while we were all absorbed in that aspect, something else was changed by Avery. The plate numbers have changed size. The first appearance of a larger digit occurred in the green 6 of number V36. Thus that number has two digits that differ in size. The gray digit 4 then went to the larger size in plate number V46. That gave V46 both digits in the larger size. Digits below gray 4 and green 6 all appear to be the smaller type. Check your copies to see if any of the lower numbers, V11 through V35, have anything but the small digits. Some of those lower numbers in my possession have tiny variations in digit size but it's probably simply due to ink density.

Huge Response to Toys B11111

I am amazed by the response to last month's item about used examples of Antique Toys number B11111. I have been swamped with e-mails, letters and one phone call replying to what was more or less a rhetorical question -Are they scarce? In over ten years of writing this column I cannot remember a greater reaction to anything that appeared here. One member even sent me a cover with B11111 on it. The consensus seems to be that that number used, is indeed scarce, representing about 2% of all Antique Toys used. One person dissented, stating his experience showed them to be about 10%. I can't mention everyone's name but some points made by Ken Cherry in his letter deserve note. Of 655 numbered Toys coils he has found, only 13 are B11111 and all of them came either from four far western states, CA, NV, WA and AZ, or three upper midwest states, WI, NE and IL. This suggests limited distribution. He also points out that it may be too early to be certain that B11111 used is truly scarce. He's right in both cases, but for now it is.

New Policy for CL Foreign Mailing

Recently I have been trying to use some older PNC's as postage on copies of Coil Line mailed to our foreign members, particularly those who are overseas. These members are at a disadvantage in acquiring used PNC's and can use a helping hand. The 9X12 manila envelopes always get a roller cancel, destroying the stamps. From now on CL mailed out-of-country will be sent folded in a #10, regardless of weight. Since these pieces (currently 15) are labeled and mailed separately, I can fold the paper and lend a hand to our foreign friends.

USA Flag Imperf and Miscut

Dealer Jim Nelson reports that a 37¢ Flag #7777 roll piece of 60 stamps that is imperforate and miscut has been found. The partial roll apparently contains two plate numbers along with quite a bit of valuable "scrap". Perhaps the word scrap is not appropriate in this case but used here for lack of a better description.

El Dorado Colors Confused


In last months item about the Flag Over City gold color variety I stated that PMS 156C could possibly be the ink used for the gold colored buildings. Actually PMS 156 is the normal color listed by the printer for the FOC coils. I also misquoted Doug Iams when I stated he is convinced a different ink color was used. He tells me he remains undecided whether it's really different. Rich Nazar believes the yellow color is something other than PMS 156. One thing the three of us agree on is that the true color cannot be easily determined from the plate number digit. It's just too small. And a word of caution is in order. Simply because the reported examples of the gold color have come from #1111A does not mean all stamps with that plate number are the El Dorado type. Most examples of 1111A are normal.

More Honeybee Buzz

After I stated last month that the "flying bee" varieties of the 25¢ Honeybee coil all came from the combination Optiforma/C press printing, one of our members wanted to know if that meant that the "bee missing" error also came only from the dual press output. No, it does not. These two mistakes are quite different. The missing bee is an error where the black intaglio ink simply was not printed on the paper. It's a missing color and that could happen on either the C or the D press versions due to any number of reasons. The flying bee is from a lack of synchronization during the pass through the C press. Such a lack of synchronization was possible on the D press during start-up, but not likely. A "bee missing" can be checked to verify the press. Small block tagging is from the C press. Large block tagging is from the D press.

Jumbo Holes in Sennett Flag Coil


These are really big perf holes. Finder Rob Loeffler sent a PS5 of the 37¢ Flag, plate number S1111, with what he said are the biggest holes he's ever seen in a coil, or any other stamp for that matter. I agree. This is another case of what Sennett's skiving perforation process can do. Rob said it appears to be an example of extreme wear of the cones on the skiving cylinder.





PNC ID 2003-9



This coil is considered a reprint by USPS so it had no announced date of release. It was first available in late October 2003.

This issue by Avery Dennison (AVR) uses an Atlas design similar to the earlier Atlas (PNC ID 2001-6) printed by Banknote Corporation of America (BCA).


It is available only in a roll of 10,000 and has blue backnumbers that are near the middle of the stamp. Backnumbers are 5-digits long and occur every ten stamps. Referenced from the front, the backnumber is always three stamps left of the plate number so collectors would need to collect at least a PS7 to have the plate number centered on the strip with a backnumber showing.

There are many differences between this version (AVR) and the previous BCA version. These are shown in the table below.

Backnumber Misfires


"Lightin' Bolt" 1740 from Tiffany Lamp Coil rolls larger than 100 usually have backnumbers on them. Many backnumbers are created with a dot matrix printer. Most come out as they should but occasionally something goes amiss creating the backnumber misfires shown on this page.

Collecting backnumbers without plate numbers doesn't strain the pocket book. Most backnumber-only strips can be had for double face value or less.

So as you look at the images on this page let your imagination run away as you think of interesting names for these anomalies.

In the example below from matching 10K rolls of the 3c Star, note how similar the misfires are on the top and bottom backnumbers.

The last digit in a backnumber is always zero, but if you did not know this some of the numbers below would be a challenge to discern.



Oddball Stuff

This month's installment features some interesting and oddball covers. Most of the owners of these covers sent them to me several months ago, and I apologize for the delay in sharing them with our readers.



I acquired the above cover (after months of negotiating) from fellow PNC member Rick Lancaster. The 5¢ Mountain coil on the cover has an extra set of "perfs" at the bottom which do not normally exist. See a blow up of the stamp. It is theorized that the "perfs" were intentionally made by the manufacturer in order to stabilize the web of stamps during the perforating process. These extra bottom "perfs" are usually trimmed off, but not in this case. The 5¢ Butte, 5¢ Wetlands and 25¢ Jukebox have also been reported with similar "perfs".





The lower left cover features a 33¢ Flag/City coil with a dramatic shift to the left of the green ink. The lower right cover features a 33¢ Hat #1111 with a dramatic shift to the left of the blue ink.





10.9c HANSOM CAB

The design is based on the cab shown which was built by the Brewster and Company of New York City and had a blue body with black moldings bearing light blue stripes. The hansom cab was a two-wheeled, one-horse public transport vehicle designed in 1834 by Joseph Alaysius Hansom and was in wide use during the latter half of the century.



On March 26, 1982, the violet 10.9c Hansom cab coil stamp was issued at a ceremony in Chattanooga, Tennessee, held at the Chattanooga Stamp club's 50th Anniversary show. The "Bulk Rate" legend in the stamps design indicated the intended use for the basic third-class presort rate that had gone in effect on November 1, 1981. Precanceled 10.9c Hansom Cab stamps overprinted with plain lines were produced for bulk mailers in coils of 500 and 3,000. Philatelic editions in coils of 500, without the precancel lines and were phosphor tagged.



The printed web being fed into the coil perforator with the Electric Eye Bars on the top edge of the web being misaligned resulted in the perforations being punched into the stamp design.





LOW TRANSFER


A low transfer occurs when a stamp subject is entered below its normal position on a printing plate or sleeve because of an improperly positioned transfer roller, yielding a low print in relation to other stamps on the same roll. The transfer roller is a steel cylinder bearing a raised image taken from the engraved master die, used to transfer a single original intaglio design to the multiple-subject positions of a printing plate by a rocking motion under pressure. Below are examples from three different press runs of a low transfer from Plate Number 2. This low transfer appears one stamp to the left of the number stamp and is positioned 1/2 millimeter lower than the stamps on either side.



ERROR'S, FREAKS & ODDITIES

Mis-slit rolls resulted in plate numbers being on top of the stamp instead of the bottom for seventeen of the eighteen rows from the plate. The top row having no plate number.







Refresher

Contrary to the USPS rule of disallowing marked, mutilated or covered stamps to be accepted for mailing, they designed such a program for usages themselves.

Sometime back, private overprinting was sanctioned for classes of mails whereby different rates would be established and recognized by use of a privately applied overprint designating what rate was to be charged, according to class. Such overprints were generally done by mass mailers in red.

Copies of such overprints are difficult to find and PNCs are particularly desired for making up an exhibit for display. (See ad elsewhere in this issue.)

Samples of authorized overprints are noted below.
