New information from members is shared every month in *Coil Line* and on our website www.pnc3.org.

The task of selling a collection many times falls to others who do not have much knowledge about PNCs. An inventory of the your PNC material and labeling of the PNCs you own goes a long way in making the liquidation task easier for those who follow.

The Values List to be offered next month helps with both the inventory and the labeling of the items you have. And the values on the list give the approximate worth of items you may own. On this second list produced by PNC³, values for mint PS3, PS5, used singles and PNCs on cover will be shown.

Though our current agreement with Scott publishing does not permit the use of Scott Numbers in an electronic product, it might be of benefit to members to have an electronic version of an inventory spreadsheet done with Microsoft Excel without Scott Numbers. Excel is the same tool used to do the Values List. What sequence should such a list be in? What columns besides PNC ID and Description should be included? Write me or the *Coil Line* Editor with your ideas.

The call for Estate Auctions in the October Coil Line has had little response so I think it best to shelve this idea. Karl Vinsek proposes that we describe a collection for sale in Coil Line and then have a viewing and an auction at a stamp show. Do your homework on ebay lots By Doug lams

While most ebay sellers are honest, ebay is a bit like the Wild West and some sellers are either deceptive or clueless, so you need to read the fine print. Here are a few recent coil examples that you might find entertaining.

Headline: "1895g Blue Omitted scv \$1,500."

Description: "This strip of four shows a range of blue error from complete blue to virtually no blue."

There was clearly still some blue on even the "virtually no blue" stamp and there is no such thing as a range of error. Either it is completely missing or it is a freak.

Headline: "APS CERTIFIED FREAK SC2282 x 2 WITH CERTIFICATES"

Description: The certificates stated "no gum, genuine, with adhesive offset from tape."

These were from the beginning of a roll and showed the stripes of white adhesive left behind from the wrapper used to seal the roll.

Headline: "US #1895, PNC5, #4, mint, nh, sound, \$575.00"

Description: "Stamps are mint, never hinged and sound with riffed perfs at right."

From the image, riffed evidently means missing. Sound indeed!

Printing information for 37c BEP stamp

The following information is a compilation of the production data Rich Nazar received from the BEP in response to his Freedom of Information Act (FOIA) requests spanning the previous year to my most recent FOIA response. During this time, the BEP only printed self-adhesive 37¢ Flag coil stamps for rolls of 100. He is awaiting a response to a pending BEP FOIA request that will contain data through November 2004.

A summary of the 37¢ Flag coil - PSA (480-subject cylinders) printing data follows:



(5c) NDN Seacoast (SA) (AP) Serpentine die cut vertically

The Black Ghost




To the left is a newly discovered variety of the (5c) Nonprofit SA Seacoast from Ashton-Potter with Serpentine die cuts on two sides (vertical sides). The variety is called the "Black Ghost".

In the plate number P2222, the letter "P" and the last "2" are black characters. Each


black character has a shadow of itself just to the left of the darker printed character. It's not known what caused this. P2222 is the only plate number so far for PNC ID 2003-5.22. The "Black Ghost" has only been observed on rolls with top back numbers.

Yellow Shift Black Ghost




On this "Black Ghost" variety, the yellow printing cylinder is shifted far enough to the right that the yellow "2" is printed underneath the black "2". The shift also causes a light yellow line on the top right hand portion of the stamp. Because the yellow printing cylinder is slightly below the black printing cylinder, a small portion of the yellow "2" shows beneath the black "2".

Because yellow is a hard color to illustrate in a black and white publication, the images below and to the left may now show up very well. Perhaps our Webmaster will show these images on the PNC3 website so you can better observe them.



To the left is a new version of the Seacoast with Plate number P2222. The original P2222 had serpentine die cuts on all four sides. The new major variety has serpentine die cuts on only two sides. The chart below shows that the new version reverts to the common practice of serpentine die cuts on the sides with straight edges top and bottom.

The P2222 with serpentine die cuts on two sides only was first reported on the PNC³ website (www.pnc3.org) on September 20, 2004.

As on the original P2222, plate numbers are 27 stamps apart. Back numbers can be 2, 3, 4 or 5 digits in length and occur on every tenth stamp. Because the plate interval is odd, back numbers can be found on all positions relative to the plate numbered stamp.

New Paper and Tagging on Self-adhesive 37¢ Flag Coil of 100 by BEP

Bureau of Engraving and Printing (BEP) stamp production records recently provided in response to a Freedom of Information Act (FOIA) request show that the BEP printed some self-adhesive 37¢ Flag coil stamps for rolls of 100 stamps on "non-phosphored" paper and then applied phosphorescent tagging over the printed image. The new variety has not been reported as having been found by collectors or dealers yet, but it should be easy to distinguish from the same design printed by the BEP on prephosphored paper.

The BEP began printing the self-adhesive 37¢ Flag coil stamp for rolls of 100 stamps on June 11, 2002. Since that time, this issue is the only stamp being printed by the BEP. (Although the BEP has produced most USA postage stamps over the last 111 years, it will end its postage stamp production in 2005—completing the transition of all USPS stamp production from the government facility to competing private stamp printers.)

All printing for this issue was done on the BEP's Andreotti (601) press using sets of four cylinders (one for each color used in the gravure printing process-yellow, magenta, cyan, and Each of the 480-subject black). cylinders (20 rows high by 24 images around) prints one color of the multicolor stamp image and one of the digits in the cylinder combination (or plate number). So far, the BEP has used the following 12 cylinder combinations to print this issue: 1111, 2222, 3333, 4444, 5555, 6666, 7777, 8888, 9999, 1111A, 2222A, and 3333A. Cylinder combinations 2222, 3333, and 8888 were re-chromed and used on second press runs.

All 12 cylinder combinations for this issue were printed on prephosphored paper (LP797). However, a month after a brief test, the BEP began printing the 37¢ Flag coil stamp on "non-phosphored" paper on October 28, 2004.

The new paper was produced by the same paper supplier as the previous but ít had different version. specifications (most notably, it was not prephosphored paper) and because of this, it had a different designation-LP800. In total, 23 rolls of "nonphosphored" paper web were used switching before back prephosphored LP797 рарег November 2, 2004. All production using the "non-phosphored" paper printed using cylinder combination 3333A. This cylinder combination, therefore, exists on two different papers with different types of tagging. According to BEP records, 198,300 cylinder impressions were made from set 3333A on the "nonphosphored" paper. This equates to about 10 percent of the total impressions from set 3333A through November 2004.

Although the BEP records explain that the stamps printed on the "non-prephosphored" were coated with taggant at the last station on the printing press, we currently do not know if the tagging was applied as "block tagging" over each stamp image or "overall tagging" across the printed web. Regardless of the type of tagging (block or overall), each of these stamps will have the taggant on top of the four colors of ink that make the stamp's printed image. In contrast, the stamps printed on the

prephosphored paper will have the tagging in the paper—and, therefore, will be present across the entire stamp and be below the colored inks of the printed image.

The reason for using the "non-phosphored" paper is not noted in the BEP reports, but a likely explanation may be linked to the approaching end of the BEP's stamp production in 2005. It is possible that the rolls of LP800 paper were remaining from the production of a previous issue—such as the (5¢) Wetlands coil, which was last printed in September 2002—and the BEP used it for the 37¢ Flag coil as a cost-saving measure.


An interesting possibility exists that some of the self-adhesive 37¢ Flag coil stamps printed on the "non-phosphored" paper may end up as untagged errors—a possibility that hasn't existed for many years on first-class rate coils since the predominant use of prephosphored paper.

Cylinder combination 3333A of this issue was originally found in post offices in late October 2004. The new variety, printed on the "non-phosphored" paper with the new tagging, will likely be distributed in December 2004 or early in 2005. Who will be the first to find it?

One member reports finding only one copy of the Avery Mountain #V333323 with round corners in searching more than 200 pounds of precancels. Should we include this die variety in the survey? Please look over your holdings and let me know if you have this number with round corners. I myself have one mint PS/5 and 2 used among my holdings. I did not think this to be an uncommon variety, so need more member input.

No reports yet on the Avery Mountain #V333343 round corner die variety. Has anyone seen one of these? Remember, this is corners, not shoulders we're talking about here.

Last month I promised more on shoulders (some call these 'transitions') and corners. The best way to describe is to illustrate.



Doug lams pointed out that last month's table of FOP rarities differed substantially from the original table in the September issue. Also Alan Thomson reported that his records of the FOP 'Famous Five' are being updated and that there are differences between what he has and the table listing as well. I'll get coordinated with Alan (since I know his records to be more detailed) and update the FOP table next month. That will form the new baseline for FOP rarities reports.

I've had some good inputs since last month on the newer die cut rarities. Here's the updated table on them.



There was a report of mottled tagging on a 10K roll which was withdrawn - since then there has been another report that has not been confirmed.

So far, the only back # on plate # strips that have been reported on the large roll self-adhesive 37c Flag from Sennett have mottled tagging, dead red ink, and top 4 digit back numbers (3K roll).
